The records of this office show that one Benjamin Davis enlisted March 2, 1777, as a private in Capt. Stephen Ashby's Company, 12th Virginia Regiment, commanded by Colonel James Wood, Revolutionary War; that he was transferred about June, 1778, to Lt. Col. John Nevill's Company, 4th, 8th and 12th Virginia Regiment, commanded by Colonel James Wood, and that he was again transferred about October, 1778, to Colonel James Wood's Company, 8th Virginia Regiment. His name last appears on the company muster roll for February, 1779, which shows him absent sick. No later record of him has been found.

The name Laney Davis has not been found on the rolls on file in this office of any organization of Virginia or Continental troops in service during that war.

The collection of Revolutionary War records in this office is far from complete and it is suggested as a possibility that information relative to the within mentioned Laney Davis can be obtained from the Librarian, Virginia State Library, Richmond, or from the Commissioner of Pensions, Washington, D. C.
