John Nevill's Company, 4th, 8th and 12th Virginia Regiment, commanded by Colonel James Cod, and that he was again transferred about October, 1778, to Colonel James Codi Company, 8th Virginia Regiment. His name last appears on the company muster roll for February, 1779, which shows him absent sick. No later rec erd of him has been found.

The name Laney Davis has not been found on the rolls on file in this office of any organization of Yirgin in or Continental troops in service during that war.
